The Japanese Society for Geographical Sciences (JSGS) publishes an academic journal, *Geographical Sciences (Chiri-Kagaku)*. It aims to advance the knowledge in geography and geographical education while promoting the field of geography in society. We welcome studies related to geography and geographical education including physical and human geography.

Journal Information

Geographical Sciences (ISSN: 0286-4886) is an open-access (after one year), peer reviewed academic journal. Anyone can submit an article regardless of their membership status in the JSGS as long as it is written in English. However, you need to be a member to submit an article in Japanese. The editors of this journal accept original articles, short reports, review articles, forums, and symposium reports on topics associated with geography and geography teaching.

Review Process

JSGS employs a single-blind review, where the referees remain anonymous throughout the process. A manuscript will be assessed by multiple reviewers, including experts outside the editorial board, and the final decision will be made by the editorial board. Typically, the manuscript will be reviewed within 2–3 months. Should the referees' reports contradict one another, or a report is unnecessarily delayed, a further expert opinion will be sought. The revised manuscript will be returned to the initial referees within two weeks. Referees and editors may request more than one revision of the manuscript. After the final decision, the editorial board can seek to modify the manuscript.

Ownership and Management

Geographical Sciences (Chiri-kagaku) is owned and managed by JSGS, which is financed through membership of the society.

Copyright

After submission and following peer review, the editors are responsible for deciding whether a paper is to be accepted. The JSGS acquires full and exclusive copyright upon its publication. Permission should be sought for reproduction and/or use in any form or by any means. Requests for copyright permission should be sent to: syomu@chiri-kagaku.jp

Publishing Fees

No publishing fees to authors whose articles are published in black and white. However, there will be processing fees for color production. The amount of processing fee varies by article length. The editorial office will notify the processing charge before the production.

Access to Published Articles

Hard copy

Members will have access to a hard copy of the journal that publishes four issues a year. For non-members, only the first author will receive a hard copy for free. Additional copies can be request with charge.

J-Stage (open-access)

All published articles will be archived on J-Stage and made available as open-access after one year of publication in the journal.

Publication Ethics and Publication Malpractice Statement

The Japanese Society for Geographical Sciences (JSGS) is committed to upholding high-quality scientific publications. The prevention of publication malpractice is an important responsibility of the editorial board.

Plagiarism is not acceptable in submissions. Plagiarized content will not be considered for publication. Plagiarism includes, but is not limited to:

- Directly copying text from other sources without attribution
- Copying ideas, images, or data from other sources without attribution
- Reusing text from your own previous publications without attribution or agreement of the editor
- Using an idea from another source with slightly modified language without attribution

If plagiarism is detected during the peer review process, the manuscript may be rejected. If plagiarism is detected after publication, we may issue a correction or retract the paper, as appropriate.

To ensure integrity in our scholarly publishing, all related parties — editorial board, reviewers, authors, and publisher — are required to follow ethical standards in performing their respective roles.

Duties of the Editorial Board Members

Fair play

Submitted manuscripts are evaluated solely on their intellectual merit without regard to race, gender, sexual orientation, religious belief, ethnic origin, citizenship, political philosophy, or the institutional affiliation of the authors.

Confidentiality

Editorial board members must not disclose any information about a submitted manuscript to anyone other than the corresponding author, reviewers, potential reviewers, other editorial advisers, and the publisher, as appropriate. This will not apply when a duplicate submission of the same manuscript is suspected.

Disclosure and conflicts of interests

Unpublished materials disclosed in a submitted manuscript must not be used in the editor's own research without the explicit written consent of the author(s).

Publication decisions

Editorial board members are responsible for deciding which of the articles submitted to the journal should be published.

Corrections, expression of concern, or retraction.

If there are concerns about potential errors, research or publication ethics, misconduct, or other issues pertaining to the integrity, validity, or reliability of an article or submission, please contact our journal directly by email. When notifying the editors of concerns, provide the full citation of the article in question and details as to your specific concerns, based on evidence.

The editors will investigate concerns raised about publications. We will take steps to correct or clarify the scientific record, if necessary, which may include issuing a correction, expression of concern, or retraction.

Complaints

The Editors of *Geographical Sciences (Chiri-kagaku)* are under no obligation to send submitted manuscripts for review. They are also under no obligation to follow reviewer recommendations, favorable or negative. Peer review is undertaken on condition of anonymity and the Editors will

not disclose the identity of peer reviewers to authors or others. Our Editors are ultimately responsible for the selection of all its content, and their editorial decisions may be informed by issues unrelated to the quality of a manuscript, such as suitability for the journal as outlined in the Information for Authors. The Editors reserve the right to reject any article at any time before publication, including after acceptance if concerns arise about the integrity of the work.

Duties of Reviewers

Contribution to editorial decisions

Peer reviews assist the editorial board in making decisions and, through editorial communication with the author, may also assist the author in improving the manuscript.

Promptness

If any reviewer feels that it is not possible for him/her to complete the review of the manuscript within the stipulated time, the reviewer is bound to communicate this to the editor, so that the article can be sent to another reviewer.

Confidentiality

Information regarding manuscripts submitted by authors should be kept confidential and be treated as privileged information.

Standards of objectivity

Reviews should be conducted objectively and impartially. Personal criticism of the author is unacceptable. Reviewers should express their views clearly with appropriate supporting arguments and should identify relevant published work that has not been cited by the authors. Any statement that an observation, derivation, or argument has been previously reported should be accompanied by a relevant citation.

Disclosure and conflict of interest

Privileged information or ideas obtained through peer reviews must be kept confidential and not used for personal advantage. Reviewers should not consider manuscripts in which they have conflicts of interest resulting from competitive, collaborative, or other relationships, or connections with any of the authors, companies, or institutions connected to the papers.

Duties of Authors

Reporting standards

The authors reporting the results of original research should present an accurate account of the work performed as well as an objective discussion of its significance. The underlying data should be represented accurately in the manuscript. A paper should contain sufficient detail and references to permit others to replicate their work. Fraudulent or knowingly inaccurate statements constitute unethical behavior and are unacceptable.

Originality and plagiarism

The authors should ensure that they have written entirely original works, and if the authors have used the work and/or words of others, they should make sure that the text has been appropriately cited or quoted.

Multiple, redundant, or concurrent publication

Authors submitting articles to the JSGS affirm that the manuscript contents are original. Furthermore, they warrant that their article has neither been published elsewhere nor is it under

review for publication anywhere. Submitting the same manuscript to more than one journal concurrently constitutes unethical publishing behavior and is unacceptable.

Acknowledgement of sources

Proper acknowledgement of the work of others must always be given. Authors should also cite publications that have been influential in determining the nature of the reported work.

Authorship of the paper

Authorship should be limited to those who have made a significant contribution to the conception, design, execution, or interpretation of the reported study. All those who made significant contributions should be listed as co-authors. If there are others who have participated in any substantive aspects of the research project, they should be acknowledged or listed as contributors.

Disclosure and conflicts of interest

All authors should disclose in their manuscript any financial or other substantive conflicts of interest that might be construed to influence the results or interpretation of their manuscript. All sources of financial support for the project should be disclosed.

Fundamental errors in published works

When an author discovers a significant error or inaccuracy in his/her own published work, it is the author's obligation to promptly notify the journal's editor-in-chief or publisher and to cooperate with them to either retract the paper or publish an appropriate erratum.
